

Fiserv EFT and AFFN Extend Network Switching Contract; New Agreement with Armed Forces Financial Network Continues to 2009

BROOKFIELD, Wis., Jun 20, 2006 (BUSINESS WIRE) -- Fiserv EFT, a unit of Fiserv, Inc. (Nasdaq:FISV), and the Armed Forces Financial Network (AFFN) have signed a contract extension for network switching services through December 2009. Under the agreement, Fiserv EFT will continue to provide comprehensive automated teller machine (ATM) and point-of-sale (POS) gateway services for AFFN.

AFFN and Fiserv EFT have partnered since 1985 to provide all U.S. military personnel - active, reserve, dependents and retired - with ready access to their funds through ATM and POS terminals worldwide.
