Mobile MoneySM from Fiserv Incorporates RenderRightTM Engine to Deliver a Customized User Experience

Rendering engine technology was developed by Fiserv mobile solution partner M-Com

(NASDAQ: FISV), the leading global provider of financial services technology solutions, today announced that the company's Mobile MoneySM and Mobile Money FastTrackTM financial service solutions now incorporate RenderRightTM from M-Com, a new rendering engine that customizes the mobile banking interface to a user's specific mobile device.

RenderRight accesses a database of information about specific mobile devices and their respective features and functionalities to automatically populate pertinent service attributes onto the mobile device. This ensures that the user has an accurate view of the application, with text or icons located in the correct area of the screen, and that all functionalities displayed are supported by the device. For example, a phone with a touchscreen will display mobile banking functionalities as icons that can be accessed by tapping them, whereas a mobile device without touchscreen capability might display the same functionalities within a text menu accessed through the phone's keys.

The incorporation of RenderRight enables Mobile Money from Fiserv to optimize mobile banking services on a broad range of mobile devices, including Blackberry[®] smartphones, the Apple[®] iPhoneTM and the recently released Palm PreTM. The RenderRight engine was developed by M-Com, which has been a Fiserv partner since September 2008.

"Consumers have high expectations regarding the functionality of mobile services, and many are not willing to give an application a second chance if it is hard to navigate," said Calvin Grimes, mobile solutions product manager, electronic banking services, Fiserv. "Customizing the user interface with RenderRight enables Fiserv to deliver a positive user experience that can lead to increased adoption and a positive return on investment for financial institutions that offer mobile financial services."

Mobile Money from Fiserv is the industry's most complete mobile banking and payments solution, supporting consumers on all three mobile access modes: mobile browser, SMS (text messaging) or a downloaded application. Mobile Money can include functions such as balance inquiries, transaction history, account transfers, bill payments and one and two-way account alerts, and offers both online and offline enrollment capabilities.
