## **Fiserv Gives Back by Delivering Toys in 15 Communities including Wallingford, Conn.**

**Wallingford, Conn., December 19, 2011** - [Fiserv](#), Inc. (NASDAQ: FISV), a leading global provider of financial services technology solutions, announced today that Fiserv associates in communities across the country, are delivering toys for the holidays and giving back by volunteering and supporting organizations in their local communities and around the world.

In the U.S., Fiserv is supporting the [U.S. Marine Corps Toys for Tots](#) drive in 12 cities: Brookfield, Wis., Hickory, N.C., Hillsboro, Ore., Houston, King of Prussia, Pa., Lake Mary, Fla., Lincoln, Neb., Norcross, Ga., Phoenix, Ariz., Sioux Falls, S.D., South Bend, Ind. and Wallingford, Conn. The U.S. Marine Corps Toys for Tots is a national, nonprofit program that collects new, unwrapped toys and distributes these toys as Christmas gifts to underprivileged children in the community in which the campaign is conducted.

Similarly, Fiserv locations are continuing the tradition of delivering toys via organizations they support locally. The Dallas office is donating toys through [Salvation Army](#), Morris Plains, N.J. office is giving toys through [Angel Tree](#), the Pittsburgh office is providing toys through the Salvation Army's [Treasures for Children](#), the Wallingford, Conn. and Norcross, Ga. offices are also collecting toys for local, adopted families and the Lincoln, Neb. office is also holding a toy drive for [CEDARS Home for Children](#).

Fiserv estimates its associates have delivered nearly 1,000 toys this holiday season.

"With more than 19,000 associates in 200 locations around the world, Fiserv has made it a priority to care globally and act locally this holiday season," said Judy DeRango Wicks, vice president, Communications, Fiserv. "Teamwork on programs like Toys for Tots enables us to work together to bring joy to others as we take an active role in our communities to make a personal and cumulative impact."

Associates of the Wallingford office partnered with Toys for Tots to hold a holiday toy drive, in which associates donated toys to benefit the New Haven area Toys for Tots program. Wallingford associates also participated in the 22nd annual [Trees of Hope](#). Corporations, local businesses, and community groups decorate trees and the trees are displayed throughout a 9-day raffle and silent auction. All funds raised are donated to the [Ronald McDonald House of Connecticut](#).

In addition to holiday activities, in 2011 the Wallingford office raised money for two [American Cancer Society](#) fundraising events, Daffodil Days and Making Strides for Breast Cancer, held a blood drive for the American Red Cross, and collected 120 pounds of food and grocery store gift cards for the [Connecticut Food Bank](#).

In addition to team projects, the company has donated to two organizations, [Feeding America](#) and [CARE International](#), as its holiday thank you in honor of its 16,000 financial services clients.

Fiserv core values are demonstrated by supporting the communities in which its associates live and work, with a focus on youth service organizations and providing assistance in the areas of health and wellness, education and financial literacy. These contributions included both monetary support and the organization of volunteer efforts. The company has a volunteer network called "Fiserv Gives Back" in which more than 7,500 hours have been logged to 121 different organizations just in 2011.
